#### Welcome & Call to Order

Chairperson (President) Fred B. Huntley welcomed those in attendance and called the meeting to order at 7:30pm

## 2. Minutes of 2016 Annual General Meeting

# 5. Reports

The following are summaries of the reports, unless noted otherwise. The full reports are on file in the secretary's record book.

## A. President's Report

Fred Huntley presented the VSCD President's report. He began by thanking the membership for the privilege of holding this position for two years. He noted that membership continues to grow. He expressed thanks to Garth Gordon and the Burns Committee and volunteers for a successful Burns Supper, to Duncan and Maggie Keppie and Rob Raeside for their dedication, to the Executive Committee and to Janet Whitman, Treasurer. He made special mention of the passing of long time member and friend, Andrew McRae.

## B. Treasurer's Report

Janet Whitman presented the financial statement for the Valley Scottish Country Dancers covering the period from May 6, 2016 to May 17, 2017. There was a balance forward \$3,534.53. Regular class fees and expenses resulted in a profit of \$2,158.00. The advanced class has a loss of \$112.00 and the Burns supper a profit of \$184.75. Other expenses to the group being: socials total \$125.00, bank fees were \$38.25 and administration fees amounted to \$327.29, Instructor bonuses were \$800.00. Card, gift and miscellaneous items were \$127.71. Total Income was \$9,616.00, total expenses were \$8,903.50 leaving a profit of \$712.50 and a current balance of \$4,247.03. The Society books have been audited and approved by Ken McRae.

### C. Webmaster's Report (Full Report)

Rob Raeside maintained the website through the year, providing details about the regular classes, advanced classes, Burns night, special dances, and other events, as well as links to relevant suppliers and other Scottish Country Dancing websites. The webhost was taken over last year by Aabaco Small Business and the statistical interface has been "simplified". It is not possible to provide the exact number of site visits, but graphically it appears that web visits have declined slightly since last year (estimate of 200 hits). Activity peaks around December and January, and again in May, when special events are being arranged. The website is available as a resource to all members if people want to post relevant information. Duncan Keppie and the current president are provided with full information how to access the site. ## D. Burns Night

Garth Gordon prepared the report which was read by co-chair, Keith Austin. The 42<sup>nd</sup> Annual Burns Supper was held at the Port Williams Community Centre on January 21<sup>st</sup>, 2017. The planning committee comprised Keith Austin, David Cameron, Garth Gordon, June Jain, Edna Mclean, Inge Mair and Patrick Loughnane. Approximately 175 attended the event. Mike Butler was MC, Rob Raeside addressed the Haggis, June Jain was the Haggis Bearer and Sandy MacMillan the piper. Our toasters were Kent Williams, Sherman Williams, Robin Bustin, Jane Bustin, and Christy Ann Conlin (Immortal Memory). The Selkirk Grace

and After Grace (in English and Gaelic) were given by Rev Ivan Norton and Murdina McRae, respectively.

Sincere thanks were noted as follows to: Pat Loughnane and staff, the Macadians and guest fiddler Heather Cameron, the Ceilidh performers, the superb haggis makers, Wendy and Rob Raeside, and David Cameron. As well, we thank Brian Tupper and the Port Williams Community Hall staff. The Committee is grateful to all who contributed time and talent in making the event a success. Financially, we realized a modest surplus of \$184.75.

## E. Teachers' Reports

#### Regular Classes

The report was read by Maggie Keppie. Teachers were Rob Raeside, Maggie and Duncan Keppie. Weekly classes were generally well attended, often with 5 to 6 sets on the floor. The general pattern included a simple warm-up dance, a few minutes of limbering up exercises and then two dances for all to enjoy. After that, the group split into two levels, with the more advanced dancers working in another room with Duncan. The two groups rejoined after the break.

The group enjoyed a social at the mid-point of each term, an end of term social in December and the annual Burns Supper in January. We look forward to the end of term social on June 10<sup>th</sup>.

A special dance, A Tribute to Wendy, was created as a thank you to Wendy Raeside for her many contributions over the years. Some of the dancers participated in a Ceilidh for the residents of Kings Riverside Court in January, a special Royal Tea Dance in May at Truro to celebrate the 35th year of the RSCDS in Nova Scotia, and also an evening of dancing at an environmental education conference at Acadia during the long weekend in May. Twelve dancers were invited to Tara and Dan's wedding to help demonstrate Scottish Country dancing and encourage guests to participate in the Grand March and several simple dances.

#### **Advanced Classes**

The report of the advanced class was read by Duncan Keppie. Seven advanced classes were held with 1-2 sets each time. Various new formations were on the program each month, including: Mairi's Wedding Reels, Schiehallion Reels, Ancient Poussette, Snake, Crossover Reels, Tandem Reels and Intersecting Reels.

#### Wilmot Group (Summary for information only)

The Wilmot Group generally has two sets of three dancers each week. There are two terms lasting eight weeks. The cost is \$5/class to pay for the Hall rental in Wilmot. Classes are free once the Hall is paid for. There is no teacher salary. Sue Van Horne expressed appreciation to the Valley dancers who attended the end of term dance and social at Wilmot in May.

### 6. New Business

Revision of Bylaws (distributed in advance of AGM to members by email)

MOTION: to approve revisions to the bylaws

Rob Raeside reviewed the main changes to the bylaws as amended:

- · Incorporation of gender-neutral language
- Fiscal year to run from May to May
- Appointment of auditor not required, sufficient to have financial reviewer
- Modify quorum for AGM from ½ of membership to ¼ of membership
- Executive Committee to include Burns Night Committee Chair
- Executive Committee to include Events Coordinator
- Votes of the Executive Committee may be made electronically
- Class instructors will include instruction for an Advanced Class
- Duties of Burns Night Committee Chair and Events Coordinator outlined
- New position of Webmaster
- MOTION: to amend the motion, to remove the position of Webmaster from the Executive Committee.

No discussion ensued. Motion carried
